Section 1 | Scholarship Information

I. BOC-CUHK International Scholarship

CUHK Business School is collaborating with the Bank of China (Hong Kong) (BOCHK) to offer this scholarship to outstanding ASEAN students.

Eligibility: ASEAN students admitted into CUHK Business School Master's programmes.

Scholarship Amount: 60% of the tuition fee for one of these programmes: Master of Accountancy, MSc in Actuarial Science and Insurance Analytics, MSc in Business Analytics, MSc in Finance, MSc in Information Science and Technology Management.

Practicum Project: Scholars will work on a project sponsored by the BOCHK.

Career Opportunities: Scholars who complete their programmes successfully will gain priority in interview opportunities to join Bank of China offices in Hong Kong and Southeast Asia.

II. Master's Admission Scholarships

Around 5%-25% of qualified applicants in each Master's programme cohort will be awarded admission scholarships, where the amount ranges from 10% to 75% of the tuition fee, with a few very outstanding students awarded full-tuition scholarships.

IV. MBA Scholarships

Applicants to the MBA programme are expected to have at least two years of post-qualification work experience by the time they commence their studies. The MBA office offers scholarships of up to full tuition fees to applicants who demonstrate outstanding academic performance, work achievements, and potential contributions to the cohort. Section 2 | Internship and Flexible Visa Policy for Non-local Graduates (IANG)

Full-time non-local students are allowed to join internships during their studies for up to one year or one-third of the normal duration of the registered programme, whichever is shorter.

The Hong Kong SAR Government Immigration Department has relaxed some immigration policies to make it easier for international students to remain in Hong Kong after graduation, to seek full-time employment opportunities. Full-time non-local students in locally accredited programmes at degree Kong months level above can remain in Hong for 24 or under the IANG (Immigration Arrangements for Non-local Graduates) policy.
